

Lazy E Pontoon Rental, LLC – Damage Waiver Agreement

This Damage Waiver is offered by Lazy E Pontoon Rental, LLC as an optional protection plan for renters. The Damage Waiver reduces the renter's financial responsibility for certain accidental damage to the rented pontoon vessel, subject to the terms, exclusions, and coverage limits described below. **This Damage Waiver is not insurance.**

Optional Damage Waiver Plans

Option 1 – Standard Protection

- \$35 – One Day Rental
- \$65 – Two Day Rental
- \$95 – Three to Seven Day Rental

Coverage: Reduces renter responsibility for accidental damage to the rental vessel up to \$1,500 total with no deductible.

Option 2 – Premium Protection (Most Popular)

- \$50 – One Day Rental
- \$95 – Two Day Rental
- \$135 – Three to Seven Day Rental

Coverage: Reduces renter responsibility for accidental damage to the rental vessel up to \$3,000 total with no deductible.

Important Terms and Conditions

1. **Optional Purchase:** The Damage Waiver is optional and may be declined by the renter. If declined, the renter accepts full financial responsibility for all damage to the vessel during the rental period.
2. **Coverage Limits:** Coverage is limited to the maximum dollar amount listed under the selected waiver option. Any repair costs exceeding the coverage limit remain the responsibility of the renter.
3. **Covered Damage:** The Damage Waiver applies only to accidental damage occurring during normal recreational use of the vessel during the rental period.
4. **Exclusions:** The Damage Waiver does not apply to damage resulting from:
 - Negligent or reckless operation of the vessel
 - Operation while under the influence of alcohol or drugs
 - Operation by any person not listed or approved in the rental agreement
 - Intentional damage or misuse
 - Violation of federal, state, or local boating laws

- Violation of Lazy E Pontoon Rental, LLC rental policies or safety instructions
- Damage resulting from towing prohibited items or unsafe activities

5. Propeller, Lower Unit, and Grounding Damage: Damage caused by operating the vessel in shallow water, running aground, striking underwater objects, sandbars, rocks, or debris may be excluded from coverage under this Damage Waiver and may remain the renter's financial responsibility.

6. Lost or Missing Equipment: This Damage Waiver **does not** cover lost or missing equipment including but not limited to anchors, ropes, life jackets, tubes, bumpers, or other provided accessories.

7. Reporting Requirement: Any accident, damage, grounding, or mechanical issue must be reported to Lazy E Pontoon Rental, LLC immediately during the rental period.

8. Gross Negligence Clause: If damage results from gross negligence, illegal activity, unsafe operation, or violation of the rental agreement, Lazy E Pontoon Rental LLC reserves the right to void the Damage Waiver and hold the renter responsible for the full cost of repairs.
